(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2025

NOTICE IS HEREBY GIVEN that Lancashire County Council have made an Order under **Section 14(1) (a) of the Road Traffic Regulation Act 1984**, as amended, the effect of which will be to temporarily prohibit traffic on the roads set out in this notice.

1. No person shall cause any motor vehicle to proceed over the following lengths of highway in the borough of West Lancashire;
 - i. A5147 Gorsuch Lane, Scarisbrick from its junction A570 Southport Road to its merging with A5147 Halsall Road
 - ii. A5147 Halsall Road, Halsall from its merging with A5147 Gorsuch Lane to its merging with A5147 New Street.
 - iii. A5147 New Street, Halsall from its merging with A5147 Halsall Road to its merging with A5147 Mill Brow.
 - iv. A5147 Mill Brow, Halsall from its merging with A5147 New Street to its merging with A5147 Southport Road.
 - v. A5147 Southport Road, Downholland from its merging with A5147 New Street to its merging with A5147 Wanisher Lane.
 - vi. A5147 Wanisher Lane, Downholland from its merging with A5147 Southport Road to its merging with A5147 Delf Lane.
 - vii. A5147 Delf Lane, Downholland from its merging with A5147 Wanisher Lane to its merging with A5147 Mairscough Lane.
 - viii. A5147 Mairscough Lane, Downholland from its merging with A5147 Delf Lane to its boundary with Sefton.
2. Nothing in this order shall apply to persons engaged in the carrying out of the works.
3. The prohibition will be operative daily from 0930 hours to 1500 hours from Thursday 20th March 2025 until Friday 28th March 2025 The prohibitions will only be operative when indicated on site by the presence of the appropriate traffic signs in accordance with The Traffic Signs Regulations and General Directions 2016. **Works are weather dependent and may not be carried out on the dates specified.**
4. Access for emergency services will be maintained whenever and wherever possible.


5. Vehicular access for residents will be maintained whenever and wherever possible. Pedestrian access to properties will always be maintained.

6. An alternative route for vehicular traffic affected by the closure is via:-

A570 Southport Road – Liverpool Road North – A59 Northway – A59 Liverpool Road – A59 Holborn Hill – A59 County Road – Southport Road and vice versa

The temporary prohibition is necessary to allow carriageway surface dressing works to be carried out.
